3. Pre-Bid Meeting shall be held at Metropolitan Police Office, Ranipokhari, Kathmandu on **11<sup>th</sup> Feb, 2020 (28 Magh, 2076)** at 14:00 hours.

Electronic Bids must be submitted to the **Metropolitan Police Office, Ranipokhari, Kathmandu** through PPMO's website: [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before **12:00 noon, 26<sup>th</sup> Feb, 2020 (14 Falgun, 2076)** Documents received after this deadline shall not be accepted.
5. The Bids will be opened in the presence of Bidders' representatives who choose to attend **26 Feb 2020 (14 Falgun, 2076) at 14:00 hours at Metropolitan Police Office, Ranipokhari, Kathmandu Nepal**. Bids must be valid for a period of **90 days** counting from the day of bid opening and must be accompanied by bid security, which shall be **valid for minimum 30 days** beyond the bid validity period.
6. If the last date of submission and opening falls on a government holiday then the next working day shall be considered the last day. In such case the bid validity and bid security shall remain the same as specified for the original last date of bid submission.
7. **Metropolitan Police Office, Ranipokhari, Kathmandu** reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason whatsoever.
